Jared Foster of Native Connections described the company and presented the plans for the former Quality Precast property.

ii. Phase I ESA Proposal - \$1,195.00

The project is not likely to be in a Brownfield Plan and is not currently in a Brownfield Plan so the LBRF funding is not currently available under Michigan Act 381. Staff noted that the General KCBRA Budget includes a \$10,000 Site Assessment fund that the KCBRA has specified for use of up to \$2,000 per project for smaller projects that are not likely to increase significantly in property value.

Place motioned to approve funding the Phase I ESA with the Site Assessment Fund and Milks seconded the motion. Motion carried with Carew abstaining.

KCBRA Board requested an extension of the purchase agreement and site access agreement from the seller of the property prior to making a decision on funding.
